IT IS THE LARGEST ARTIST RESIDENCY PROGRAM IN THE WESTERN UNITED STATES AND CONSIDERED AMONG THE BEST IN THE COUNTRY. EACH YEAR DOZENS OF ARTISTS FROM ACROSS THE UNITED STATES, AND AROUND THE WORLD, TRAVEL TO THE OPEN HILLSIDES AND DEEP REDWOOD FORESTS OF SMIP RANCH TO TAKE INSPIRATION FROM THE BEAUTIFUL SURROUNDINGS AND SEEK REFUGE FROM THE DISTRACTIONS OF THE WORLD TO CONCENTRATE ON THEIR CREATIVE PROJECTS. WHILE IN RESIDENCE, THE ARTISTS WORK IN PEACEFUL ISOLATION WITHIN A SUPPORTIVE COMMUNITY OF OTHER ARTISTS AND PROGRAM STAFF.
